INTERNAL PROCESSING OF THIS APPLICATION

TREASURER: Upon receipt of a new Application, the Treasurer will retain the check and forward the Application to the Secretary.

SECRETARY:

1. Verify the Applicant's membership in El Jebel Temple.
2. Set up and control the three (3) attendance requirements.
3. Inform the El Jebel office to add the new member's name and address to the Sandblaster's mailing list.
4. Mail one (1) copy of Application form to each of the following:
 - a. President of Sandblasters
 - b. Chairman – Membership Committee
 - c. Chairman – Calling Committee
 - d. Chairman – Handicap Committee
 - e. Chairman – Shrine Jewell Committee
5. At the appropriate time, the Secretary will purchase a Sandblaster name tag for the new member and his spouse.

BY-LAWS OF THE SANDBLASTERS

(Pertaining to new members)

Article 7 of the Sandblaster By-Laws states that the Initiation Fee and the Membership Dues are set by the Board of Directors and approved by quorum vote of the membership. As of January 1, 1993 the Initiation Fee was \$35.00. The Annual Dues are \$30.00, billed annually in October and must be paid on or before January 1st; provided however, that a new member shall not pay dues in the year in which the Initiation Fee is paid or the following year if accepted for membership by proper vote after October 1.

Article 9, Membership Committee. This committee is responsible for investigating all Membership Applications and submitting their finding to the Secretary. This investigation includes "current up-to-date membership in El Jebel Temple."

SPECIAL NOTE:

The Board of Directors recommends that all members familiarize themselves with the By-Laws of the Sandblasters.
